The Catalog of Federal Domestic Assistance (CFDA) is a database of various federal assistance programs in the U.S. It provided a full listing of programs available to corporations, government agencies, U.S. territories, and individual citizens.

The U.S. federal government, through various agencies and departments, offers a range of assistance such as grants, loans, scholarships, property, and counseling. Beginning in 1984, information about these domestic assistance programs was compiled by the General Services Administration, which published it in the CFDA. Many, but not all, programs provided financial assistance.
